(1) Reason for consolidation

Fuji Logistics Co., Ltd. was incorporated in 1972 and engaged in logistics for the products of Ohayo Dairy Products Co., Ltd. and Kabaya Foods Corporation. System Mate Co., Ltd. was also incorporated in 1990 and engaged in research and development of software.

This consolidation aims the improvement the quality of services further by strengthen the cooperation and the connection on logistics and IT function. Specifically, we unify the works related to receiving orders for Ohayo Dairy Products Co., Ltd. and Kabaya Foods Corporation.
